Volunteer Income Tax Assistance (VITA) and Tax Counseling for the Elderly (TCE)

The Volunteer Income Tax Assistance (VITA) program offers free tax help to people who make \$56,000 or less, or who are persons with disabilities, 60 years of age or older, or limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.
